Julie,

I haven't read the outline in detail, only skimmed it, but on first look I can see that it needs substantial revision and shortening before it warrants discussion. These should be "outlines," not findings recast in a different format. This outline should be half the 14 pages it now is. Most of the introductory material is unnecessarily detailed -- one page of bullets hitting the high points should do. In the table, the second column from the left should be widened so that the list of references does not go on and on. In the 2nd paragraph under "Federal Status...", line spacing needs to be changed to single space. Try 11.5- or 11-point font in the document to shorten it.

Hope these ideas help.
